<p>COVID-19 TESTING</p>	<p style="text-align: center;">Testing is Prioritized and Strongly Encouraged for:</p> <p>Symptomatic persons with:</p> <ul style="list-style-type: none"> • Fever or chills, Cough, Shortness of breath or difficulty breathing, Fatigue, Muscle or body aches, Headache, New loss of taste or smell, Sore throat, Congestion or runny nose, Nausea or vomiting, and Diarrhea. <p>Symptomatic persons who are:</p> <ul style="list-style-type: none"> • Hospitalized • Healthcare workers and other first responders • Employees and residents in group living settings, and • Over 65 years old or with <u>underlying health conditions</u> that place them at higher risk of serious complications <p>Asymptomatic persons:</p> <ul style="list-style-type: none"> • If they are part of a public health investigation • If they live or work in high risk settings, such as skilled nursing facilities or homeless shelters

- If they are a close contact of someone with a confirmed positive diagnosis of COVID-19, or
- If they are an essential worker.

Prioritization of routine testing among other asymptomatic people is not recommended at this time. People over the age of 65 or with underlying conditions do not necessarily need to be tested unless they have symptoms, have had an exposure or have been told by public health to be tested. Once again, please check with your healthcare provider about your specific situation and let their medical advice guide you.

- The Los Angeles Regional Food is taking necessary precautions to make sure that food and product remain safe, and that distributions and volunteer activities can continue. For more information [Click Here.](#)
- As of 10/7/20, Access Services has completed over 256,004 meal and grocery deliveries to seniors and people with disabilities across four current projects.
- This week, #LetsFeedLACounty is hosting 2 drive-thru food distribution events (due to the holiday) 10/14 San Fernando and 10/16 El Monte Whittier.
- Total distributed to date at 39 events is 2,516 tons of food which is the equivalent 4.2 million meals provided to 71,909 households.
- Drive-thru food distribution event held last week at Whittier, Altadena and Carson where: 711; 1,200; and 1,500 households, respectively, were provided 80 pounds of food, including shelf-stable items, dairy product frozen meat, and fresh produce.

Total meals served through this program since May 12: 1,525,712. • The Great Plates Delivered Program has contracted with 69 meal providers that are employing 1,557 people. 67% of meal providers are minority-owned businesses. • Great Plates Program has been extended until November 9, 2020. • Elder Nutrition Program has a current service current population of 26,919 seniors (37% increase since June 20).
