- As of 10/14/20, Access Services has completed over 258,911 meal and grocery deliveries to seniors and people with disabilities across four current projects.
- This week, #LetsFeedLACounty is hosting 2 drive-thru food distribution events (due to the holiday) 10/14 San Fernando and 10/16 El Monte Whittier.
- Total distributed to date at 39 events is 2,516 tons of food which is the equivalent 4.2 million meals provided to 71,909 households.
- Drive-thru food distribution event held last week at Whittier, Altadena and Carson where: 711; 1,200; and 1,500 households, respectively, were provided 80 pounds of food, including shelf-stable items, dairy product frozen meat, and fresh produce.
