- If they are a close contact of someone with a confirmed positive diagnosis of COVID-19, or
- If they are an essential worker.

Prioritization of routine testing among other asymptomatic people is not recommended at this time. People over the age of 65 or with underlying conditions do not necessarily need to be tested unless they have symptoms, have had an exposure or have been told by public health to be tested. Once again, please check with your healthcare provider about your specific situation and let their medical advice guide you.

- The Los Angeles Regional Food is taking necessary precautions to make sure that food and product remain safe, and that distributions and volunteer activities can continue. For more information [Click Here.](#)
- As of 10/7/20, Access Services has completed over 256,004 meal and grocery deliveries to seniors and people with disabilities across four current projects.
- This week, #LetsFeedLACounty is hosting 3 drive-thru food distribution events 10/6 Whittier, 10/8 Altadena and 10/9 Carson.
- Total distributed to date at 36 events is 2,388 tons of food which is the equivalent 4 million meals provided to 68,498 households.
- Drive-thru food distribution event held last week at San Fernando, East LA and Arcadia where: 1,208; 989; and 1,437 households, respectively, were provided 80 pounds of food, including shelf-stable items, dairy product frozen meat, and fresh produce.
- Will have expanded to 3 distributions per week starting last week.
