TESTING

No Appointment Needed

Free COVID-19 testing is available to all LA County residents at drive-up and walk-up testing sites. **Appointments are currently not needed, and you are able to register on-site at LA County testing sites.** Appointments can still be made and can help reduce wait times. Testing highly recommended for:

- **People who have symptoms:** If you have symptoms of COVID-19, talk to a healthcare provider and get tested.
- **People who have been a close contact to someone with confirmed or suspected COVID-19 (a case) within the last 14 days.** Even if your test is negative, you will still need to complete your quarantine.
- **People with or without symptoms who are part of an outbreak response or contact investigation in high-risk settings,** such as nursing homes, congregate living facilities, correctional facilities, or persons experiencing homelessness.

VACCINE & DISTRIBUTION

LA County vaccination providers can now offer the Pfizer vaccine for 12-15-year-olds. Teens should come with a parent, guardian or responsible adult and bring proof of age. Appointments can be made at [VaccinateLACounty.com](https://www.vaccinate.lacounty.gov). Uber and Lyft are providing free rides to and from vaccination sites. Call **(833) 540-0473** to book a ride if you do not have the apps.

Through Thursday, June 3, at all the county-run vaccination sites, LA City sites and the St. John's Well Child and Family Center sites, everyone 18 and older getting their first COVID-19 vaccine or bringing a first-time vaccine recipient with them to their second dose appointment, will have an opportunity to win a pair of tickets to the 2021-2022 home season of either the LA Kings or the LA Galaxy: [Click Here](#) for more information.

As of May 6, 2021, Los Angeles County moved into the Yellow Tier of the State's [Blueprint for a Safer Economy framework](#). The State will be keeping its current masking guidance until June 15, and LA County will do the same and remain in alignment with the Los

Angeles County Health Officer Order of May 3, 2021. It is important to note that the Centers for Disease Control and Prevention (CDC) announcement last week was not meant to eliminate current safety modifications at local and state levels, and the CDC acknowledged the importance of maintaining local protections.
