TESTING

No Appointment Needed

Free COVID-19 testing is available to all LA County residents at drive-up and walk-up testing sites. Appointments are currently not needed, and you are able to register on-site at LA County testing sites. Appointments can still be made and can help reduce wait times. Testing highly recommended for:

- **People who have symptoms**: If you have symptoms of COVID-19, talk to a healthcare provider and get tested.
- People who have been a close contact to someone with confirmed or suspected
 COVID-19 (a case) within the last 14 days. Even if your test is negative, you will still need to complete your quarantine.
- People with or without symptoms who are part of an outbreak response or contact investigation in high-risk settings, such as nursing homes, congregate living facilities, correctional facilities, or persons experiencing homelessness.

VACCINE & DISTRIBUTION

LA County vaccination providers can offer the Pfizer vaccine for 12-15-year-olds. Teens should come with a parent, guardian or responsible adult and bring proof of age. Appointments can be made at **VaccinateLACounty.com**.

REOPENING & RECOVERY RESOURCES

As of May 6, 2021, Los Angeles County moved into the Yellow Tier of the State's <u>Blueprint</u> <u>for a Safer Economy framework</u>. Next week, LA County will issue a modified Health Officer Order to align with the State that will include new masking guidance, requirements for workplaces to adhere to the Cal/OSHA standards, and any needed sector-specific protocols that remain in place for schools, day cares, camps, and high-risk congregate settings. <u>Click</u> Here for more information.
