TESTING

No Appointment Needed

Free COVID-19 testing is available to all LA County residents at drive-up and walk-up testing sites. Appointments are currently not needed, and you are able to register on-site at LA County testing sites. Appointments can still be made and can help reduce wait times. Testing highly recommended for:

- **People who have symptoms**: If you have symptoms of COVID-19, talk to a healthcare provider and get tested.
- People who have been a close contact to someone with confirmed or suspected COVID-19 (a case) within the last 14 days. Even if your test is negative, you will still need to complete your quarantine.

 People with or without symptoms who are part of an outbreak response or contact investigation in high-risk settings, such as nursing homes, congregate living facilities, correctional facilities, or persons experiencing homelessness.

PUBLIC HEALTH COVID-19 CASE COUNTS

The Los Angeles County Department of Public Health is actively monitoring the number of COVID-19 cases reported throughout the County. As of 6/30/2021, 7,026,869 people in LA County have been tested for COVID-19 with 17% testing positive.
