COVID-19 TESTING	<p style="text-align: center;">Testing is Prioritized and Strongly Encouraged for:</p> <p>Symptomatic persons with:</p> <ul style="list-style-type: none"> • Fever or chills, Cough, Shortness of breath or difficulty breathing, Fatigue, Muscle or body aches, Headache, New loss of taste or smell, Sore throat, Congestion or runny nose, Nausea or vomiting, and Diarrhea. <p>Symptomatic persons who are:</p> <ul style="list-style-type: none"> • Hospitalized • Healthcare workers and other first responders • Employees and residents in group living settings, and • Over 65 years old or with <u>underlying health conditions</u> that place them at higher risk of serious complications <p>Asymptomatic persons:</p> <ul style="list-style-type: none"> • If they are part of a public health investigation • If they live or work in high risk settings, such as skilled nursing facilities or homeless shelters • If they are a close contact of someone with a confirmed positive diagnosis of COVID-19, or • If they are an essential worker. <p>Prioritization of routine testing among other asymptomatic people is not recommended at this time. For more information Click Here.</p> <ul style="list-style-type: none"> • As of 8/11/20, Access Services has completed over 229,026 meal and grocery deliveries to seniors and people with disabilities across four current projects. • This week, #LetsFeedLACounty is hosting 2 drive-thru food distribution events in Castaic and in Sylmar. • Total distributed to date at 24 events is 1,500 tons (3 million pounds) of food which is the equivalent 2.5 meals provided to 44,812 households. • Drive-thru food distribution events held last week in East Los Angeles and Paramount where 2,639 and 2,502 households, respectively, were provided 80 pounds of food, including shelf-stable items, dairy product frozen meat, and fresh produce. • Will be expanding to 4 distributions per week starting in September. • #LetsFeedLACounty has secured 400 20-pound boxes of groceries from the LA Regional Food Bank for weekly delivery through the end of December to clients of the DHS Housing for Health program. • The LAUSD “Grab & Go” Food Centers are open, Monday through Friday from 8-11a.m. through August 14, 2020. As of Monday, June 22, 2020, the “Grab & Go Food Center” at Verdugo Hills High School moved to Mount Gleason Middle School. • Issuing additional CalFresh benefits up to the maximum allowed per family and allowing CalFresh recipients to purchase groceries online for delivery from Walmart and Amazon. • Great Plates Delivered has a current service population: 4,487 seniors (7.5% increase since last week). Total meals served through this program since May 12: 608,452 (156% increase from last month) • The Great Plates Delivered Program has contracted with 57 meal providers that are employing 1,171 people. 61% of meal providers are minority-owned businesses. • Great Plates Program has been extended until September 9, 2020. • Elder Nutrition Program has a current service current population of 16,657 seniors.
