<b>SITUATION SUMMARY:</b>	<p>The following public information is a high-level summary of events being managed by the Los Angeles County Emergency Operations Center tasked with the emergency response and coordination of Countywide resources to address the COVID-19 disaster. Please share this information with your family, fellow residents, municipal, state &amp; community partners.</p> <ul style="list-style-type: none"> <li>• March 28, 2020 FEMA provided \$390 million in federal support to California and an additional \$468 million to the State to reimburse costs related to the COVID-19 response.</li> <li>• March 27, 2020 the Coronavirus Aid, Relief and Economic Security Act (CARES Act) was signed into law by President Donald J. Trump</li> <li>• March 30, 2020, Governor Newsom announced the California Health Corps, a major initiative to expand the health care workforce. <p><b>COVID19-RELATED MEDICAL SHELTERING OPERATIONS</b></p>	<p>New medical sheltering operations are currently being brought online in El Segundo, Lancaster, and Los Angeles. To increase capacity at each facility the County is recruiting and training personnel to serve as on-site managers. <b>PERSONS EXPERIENCING HOMELESSNESS</b>	<p><b>The Office of Emergency Management</b> has designated LAHSA as the lead agency for work relating to people experiencing homelessness. OEM did this to ensure that LAHSA’s expertise is captured in the day-to-day work and allows LAHSA to play the central coordinating role across City and County agencies.</p> <p>LAHSA’s goal is to provide 2,000 shelter beds where persons exhibiting COVID-19 symptoms can isolate safely. These include RVs provided by the state and hotels provided by the County. Social Distancing in shelters continues to be a priority.</p> <p>LAHSA has requested resources that include food, personnel, test kits, and a warehouse to store acquired items. This order is currently being addressed by both the State and the County. LAHSA is asking for shelter support staff including medical and shelter staff.</p> <p>The State has allocated \$50 million in State funding for the leasing of hotels/motels for three months for persons experiencing homelessness statewide. These rooms are not for medical sheltering. They are instead deemed “interim sheltering” for vulnerable persons experiencing homelessness including those over 65 years of age and those with compromised immunity or chronic disease.</p> <p>The State will take the lead on negotiating leases with hotels/motels on behalf of the County. This partnership between the County and State allows agreements to be reached quickly.</p>		
<b>HEALTHCARE SYSTEM &amp; SERVICES:</b>	<p>The County healthcare system at present time is not experiencing a shortage of hospital beds. There is, currently, no surge or demand for COVID-19 related hospital care.</p> <ul style="list-style-type: none"> <li>Private hospitals report 764 open beds and approximately 242 open ICU beds with 100% of hospitals reporting.</li> </ul>		

	<ul style="list-style-type: none"> <li>• Among 4 DHS hospitals, total of 1,394 beds; 824 occupied (59% occupancy), 570 open beds.</li> <li>• DHS ICU beds, total 168; 109 occupied (65% occupancy), total of 59 open ICU beds.</li> </ul>

<b>PUBLIC SAFETY INFORMATION:</b>	<p><b>The Los Angeles County Sheriff’s Department</b></p> <ul style="list-style-type: none"> <li>• At this moment, 9 Department members have tested positive.</li> <li>• The Department has implemented a voluntary expedited COVID-19 testing for its first responders/employees.</li> <li>• Staffing at DOC/Patrol level continue to be a priority.</li> <li>• Reallocating personnel from non-essential operations to supplement patrol and high visibility areas/ crime suppression. Today, 176 additional deputy sheriffs are on patrol ensuring residences and shuttered businesses are safe.</li> <li>• The Sheriff’s Department has identified over 253 department members who are EMT certified and 17 department members who are paramedic trained available to supplement medical personnel if they are needed.</li> <li>• Providing PPE to line personnel and ensuring exposed staff receive appropriate medical services/shelter.</li> <li>• The Sheriff’s Department continues to monitor the care of inmates within the county jail system. The Department has augmented its medical screening procedures and provided additional staffing for cleaning and decontamination. The Department continues to work with Correction Health and The Department of Health Services to make sure the inmate population is cared for appropriately.</li> </ul>

	<p><b>The Los Angeles County Fire Department</b> is completing the following activities:</p> <ul style="list-style-type: none"> <li>• Assisting in receiving and distributing medical supplies inbound from the State at the direction of the Department of Public Health. (see PPE)</li> <li>• Medical Director Dr. Clayton Kazan has taken the lead on developing a testing plan for COVID-19. Hosting daily conference calls with LAC EMS section and Medical Director.</li> <li>• Developing and expanding non-contact medicine to include telemedicine and video portals in an effort to maintain services and slow transmission through social distancing.</li> <li>• Offering mental health programs and peer support while identifying home-life challenges for personnel</li> <li>• Assisting with staging operations at Medical Sheltering facilities</li> <li>• Assisting with staffing needs at the CEOC Joint Information Center.</li> </ul>

Below is a list of County Departments and their status as it pertains to the COVID-19 local health emergency:</p> <p><b>Agriculture/Weights and Measures:</b> Continuing operations to the public and industry. Department facilities remain closed to the public. Supporting constituents with essential services such as animal intake, placement, reunification, field support, and referrals to resources. Supporting employees by minimizing interactions with the general public, providing alternate work assignments, teleworking options, and DSW assignments. **Auditor-Controller:** Implementing modifications to payroll system that will enable salary caps relating to the Families First Coronavirus Response Act. Providing guidance to departments to allow them to accept and acknowledge COVID-19 donations in accordance with IRS guidelines. Monitoring the County's ability to pay liabilities and meet critical functions. Validating all new vendors to add greater protection to the purchasing process. 69% of employees are teleworking, 19 are DSWs, and the remaining staff are working on site. The Board approved a motion by Supervisor Mark Ridley-Thomas to strengthen consumer protections against price gouging during the COVID-19 pandemic. **Chief Executive Office:** Assigned staff to telework to support Safer at Home for the foreseeable future. Continuing to monitor resource requests for staffing to support CEOC and requests for DSW staffing. **Consumer and Business Affairs:** Providing essential services and assistance to residents by ensuring that tenants/landlords have proper protections in place.

Ensuring that all price gouging allegations are investigated. Providing up-to-date information on resources, aid, or other information to residents. Providing adaptive work environment measures to employees on telework. Continue to support workers and businesses through the Los Angeles County Business and Worker Disaster Help Center and department website.

**District Attorney:** 1,043 staff are teleworking and 313 are on site. Continuing to meet all statutory and constitutional obligations. **Health Services:** Managing and dispersing the supply of ventilators to hospitals. Researching ways to repair broken ventilators that were in storage. Developing procedures to transfer patients to and from USNS Mercy and FMS. Meeting medical staffing needs with creative leveraging of staffing agencies.

**Human Resources:** Assigned SMEs as liaisons to departments to assist with CCVID-19 questions. Coordinated over 500 DSW placements. Responded to 109 email inquiries. Finalizing protocol guidance for employees who test positive for CCVID-19. Drafting FFCRA Leave Request guidance and reporting form. **Internal Services:** Providing enhanced cleaning for buildings that are operational and establish terminal cleaning protocols. Custodial services and craft services have moved to a 50% operational rotation to maximize the Safe at Home provisions. Program & Project Management is reporting 36 Facility Reinvestment Program projects are experiencing delays. Power Plant Operations supporting critical central heating and refrigeration at MLK Community Hospital, Olive View Hospital, the Hall of Administration and surrounding buildings, Pitchess Detention Center. Streamlined emergency purchasing procedures and approvals. Negotiated procurement of county medical sheltering to accommodate potential quarantines. 150 staff added to IT Help Desk. **Medical Examiner-Coroner:** Resupplying PPE to staff to ensure continued operational ability. Requested hospitals and facilities to increase refrigerated storage capacity as part of the exiting MFI plan. Assessing existing and surge capacity for hospitals and healthcare entities. Obtaining mortuary and funeral home capacity to gain understanding of the system. 6% staff teleworking and 214 are working on site.
